Dear Members and Colleagues,

I hope your start to Semester 1 has been positive and I hope, rather than expect, that you haven't experienced too much disruption from having to move, or reorganise at short notice, all of the teaching originally scheduled for the second Monday of semester (now a non-teaching day). The UWA ASA Committee would be grateful if you would share with us any data that has been collected by individuals, Disciplines, or Schools about the nature of the disruption to teaching and scheduling, as well as to research and administration.

I just wanted to update you with a couple of notable items.

## FREEDOM OF SPEECH ON CAMPUS / UWA ASA FORUM (Save the Date!)

You will be aware that there has been an ongoing discussion on campus on the topic of freedom of speech, a discussion that seems to be occurring across Australia and the world. UWA tends to feature prominently in media discussions of the issue, especially in light of the Bjorn Lomborg affair and since our Chancellor, the Honourable Robert French, was appointed to undertake a review of freedom of speech on campus. I hope that some of you have managed to contribute to the consultation on freedom of speech at UWA, led by Professor Colin McLeod who, in concert with a small committee selected by the VC, is tasked with the (unenviable) job of producing a consensus position for the University on the issues.

The relationship between freedom of speech and academic freedom is also of significance here. What the University might do, or not do, to protect staff whose teaching requires them to express controversial views is an important question. The UWA ASA Committee members hold a range of views on this, and related questions, and presume our members do too. Hence, we have decided to host a forum entitled "Trigger warnings....constrained and constraining audiences in the University"

for our members on **Thursday 4**<sup>th</sup> **April at 4pm** followed by collegial drinks and nibbles. Details of the event will be provided closer to the time, but please save the date!

I have attached an interesting piece on free speech by immediate past President of UWA ASA and current Chair of Academic Board, Professor Ray Da Silva Rosa. Ray hopes to encourage a broad based academic engagement with this question across the University and I fully support him in that hope. I also attach the first chapter of a recent book on free speech by retired UWA Political Scientist David Van Mill, and a link to one of his articles on the topic from The Conversation:
